1 ACCEPTANCE OF PREVIOUS MINUTES

Having been circulated to all members of the Council of Management, the minutes of the council meeting held on 9th June, 2025 were taken as read, confirmed, and approved.

2 MATTERS ARISING

3 **CORRESPONDENCE**

3.1 SBIA would hold SBIA OPEN 2025 from 8th to 9th November, 2025. There being no objection from councilors, the above competition was approved.

4 TREASURER'S REPORT

- 4.1 The Hon. Treasurer reported only few clubs with overdue payments exceeding 1 months, thanks to the cooperation of the clubs.
- 42 The Hon. Treasurer reminded all clubs to email bank deposit slips with the club's name to LBA after payments.

5 NATIONAL LEAGUE

VP (National League) reported the following:

5.1 <u>Premier League 2025</u>

Panel rulings:

- Deduct GLBC-A two points for a player wearing improper footwear in W0742.
- Deduct HKPBC-C one point for late verify in W0765
- Deduct KCC-E two points for insufficient player leading to game postponed in M07103
- Deduct TKOBC-A one point for late verify in M08011
- Deduct PDLBC-A one point for late verify in M09072
- Deduct SBIA-B four points for two players playing the second game (W2574) in the same fixture week. Shots of the defaulting teams were adjusted.

52 Triples League 2025

213 entries (132 men and 80 women) entries were received.

The fixture v7 was issued.

All clubs using public venues should submit their application and complete the payment before 31 Jul. Late submission might not be handled by LCSD.

53 YDT request to use TP in Triples League; VP in Premier League

YDT plans to use TP in Triples League and VP in Premier League. There being no objection, the request was approved.

5.4 ELBC request to change the home green to TCS

Due to the rejection of ELBC requesting ALC as home, they applied using TCS starting Triples League 2025. The League panel supported the application.

Now four clubs (BFC, ULBSC, AYFP, ELBC) use TCS as home. The quote is 10 sides. In Triples League 2025, 12 sides were entered by these clubs. These 4 clubs have registered a total of 8 sides in the Premier League 2025.

55 TKNA request to use TCS in Premier League; TPWP in Triples League

In the process of applying for new club TKNA requested to use TCS for the Premier League and TPWP for the Triples League as their home greens.

VP(Technical) reminded TKNA to submit their club application form to LBA in time for confirmation.

5.6 Names in the scorecards and result capture software

To prevent miscommunications and misunderstandings, please use only English names specifically your ID name or the name you applied with.

5.7 Short of player in the mid-game

League panel proposed a new bye-law 2.20, If a team cannot keep the minimum number of players during a match and the game has to postpone, 2 points will be deducted for each team.

Bye-law 2.12.f. During the middle of the game, when one team is less than the minimum number of players, one player is allowed to move from a full team to make up the team to continue the game.

There being no objection, the proposal is effective.

7 <u>DEVELOPMENT</u>

VP (Development) reported the following:

YDT player Bianca Szeto won the girls singles title and Quenton Ip progressed to quarter final at the 2025 Junior Golden Nugget in Australia.

The finals of Under 25 Age Group Lawn Bowls Championship would take place at TCS this Saturday. Thank you HKFC allowing LBA to use their indoor facility on 27 July as a fall-back venue due to typhoon.

Under 25 Indoor Pairs Competition 2025 was open for entry this week. The event would hold on 10th August and 17th August.

8 TECHNICAL

VP (Technical) reported the following:

Four players passed the umpire written examination. The green examination would take place next month.

9 <u>INTERNATIONAL</u>

VP (International) reported the following:

The Hong Kong, China team won a gold and a silver medal at the Lion City Cup. Nixon Man was also presented the Most Valued Player award.

The team of 14 players would travel to Glasgow for training camp from 16th August to 25th August, 2025.

10 <u>DISCIPLINARY PANEL</u>

The first case was a complaint from public. A resident walking by Kai Tak Bowling Greens with his daughter reported that players were using foul language to insult each other during the competition. This case had already been ruled on. The VP (Technical) reminded the players about their conduct and manner during the games, emphasizing that they represent not only their club but also the LBA and the sport of lawn bowls.

The second case was a complaint from a young player's parent. A young player wore the wrong shoes for competition, which was already been ruled. Besides, parent complained the young player was continued to scold and bullied by players from the opposite team during the competition. This matter is still handling by the Discipline Panel. VP(Technical) reminded all clubs to advise their members against provoking complaints, as lawn bowls is meant to be a leisure game.

11 HONG KONG INTERNATIONAL BOWLS CLASSIC 2025

Before the change of venue for the World Cup, LBA had already invited international teams. As a result, there are a few sponsored teams for Classic 2025 this year.

12 ANY OTHER BUSINESS

121 Convenor suggested establishing a winter schedule for next year's league competition due to concerns about the late ending of matches at night, which raises safety and traffic issues. This suggestion would be discussed on next meeting.

在W0765賽事中, HKPBC-C因遲驗證比賽結果,扣掉一分。

KCC-E因球員人數不足導致 M07103 的比賽延期,扣掉兩分。

在 M08011賽事中,TKOBC-A因遲驗證比賽結果,扣掉一分。

在 M09072賽事中,PDLBC-A因遲驗證比賽結果,扣掉一分。

SBIA-B因有兩名球員在同一賽周參加第二場比賽(W2574),扣掉四分。 違規隊伍的得分已調整。

52 三人聯賽2025

213 份報名(132 男子和80 女子)。

已發佈比賽安排 v7。

53 青少年發展隊申請在三人聯賽中使用 TP;在超級聯賽中使用VP

54 耆英草地滾球會要求將主場球場改為TCS

10 紀律小組

第一宗案件是由公眾提出的投訴。一位市民與女兒在啟德草地滾球場旁觀看比賽時,投訴選手在比賽中使用粗魯的語言互相侮辱。該案件已做出裁定。副會長(技術)提醒球員注意在比賽中的行為和舉止,強調他們不僅代表自己的屬會,還代表中國香港草地滾球總會和草地滾球運動。

第二宗案件是由年輕球員的家長提出的投訴。事源因一名年輕球員在比賽中穿著不合適的球鞋,該屬會已被處分。此外,家長投訴該年輕球員在比賽中持續受到對方隊伍球員的辱罵和欺凌。此事仍在紀律小組處理中。副會長(技術)提醒所有屬會,應提醒他們的成員不要鼓吹投訴,因草地滾球是一項休閒遊戲,一切爭執可以避免的。

11 二零二五年國際草地滾球精英賽

由於在世界盃場地變更之前,總會已經邀請了國際隊伍來港參賽。因此,今年的國際草地滾球精英賽會較少贊助隊伍。
